On the estimates of compliance in the first half of 2018 of the economic and budget indicators

The Matanzas economy is estimated to be in compliance with the total net sales plan by around 2% and a 6% growth is expected. It is noteworthy that although these results are achieved it is estimated that 3 agencies do not comply with this indicator, they are: MINDUS with the Commodity Company primarily, MINAL with the Meat Company for construction, technological and hygiene problems and the AZCUBA Company that only meets the 88% sugar plan. However, other sectors have come to fulfill contributing to the fulfillment of the plan they are: MICONS, MINAGRI, MINFAR, MININT and OLPP ...
